## FREIGHT AND LIABILITY LIMITATIONS

Complaints for any loss or damage due to the handling and deliveries of boxes, shall be made in writing by the receiver within 5 days upon receiving the box and duly endorsed to BEFF Corp. or its assigned Area Agent

## **CUSTOM AND ASSESMENT**

Connect Logistics requires sender to comply in filling up the "Detailed Packing List" properly and honestly. Shipment is subject to customs inspection and assessment. Personal effects such as clothing, toiletries, and limited number of canned goods of which is 12pcs per item for non-commercial use is exempted from taxes. Whereas highly luxurious valuable items, whether brand new or used, i.e. appliances, electrical items, bicycles, carpets, leather upholsteries, chairs, cabinets and paintings of art are definitely taxabale. Sender or consignee is obliged to comply in payment of the corresponding amount of tax required based in tariff classification of taxable items.
